

Minutes of the 52nd Annual General Meeting of the Quaternary Research Association held at University of Durham on 5th January 2017 at 16:00.

The President, Professor Pete Coxon, chaired the meeting, which was attended by 37 members of the Association:

1. Welcome and apologies for absence

The President welcomed members to the meeting. Apologies were received from Tim Atkinson, David Bridgland, Stewart Campbell, Laura Crossley, Bethan Davies, Rachel Devine, Geoff Duller, Andrew Finlayson, Neil Glasser, Michael Hambrey, Danielle Schreve, Barbara Silva and Michael Tooley.

2. Minutes of the 51st Annual General Meeting

These were accepted as a correct record of the meeting.

3. Matters arising from the minutes

There were no matters arising from the minutes.

4. President's report

a. Previous ADM. The President began his report by thanking the organisers of the 2016 ADM (held at Royal Holloway, University of London) for putting together such a professional and positive experience for all attendees.

b. Honours and awards. As part of the 2016 AGM (held during the ADM), the President had awarded medals to Tom White (Lewis Penny Medal) and Alayne Street-Perrott (James Croll Medal) and conferred Honorary Memberships on Chris Caseldine, Rick Shakesby, Tony Stuart and David Sugden.

c. Conservation issues. The President reported that the Secretary had responded in writing on his behalf to oppose a re-submitted application to develop the Callandar moraine and to highlight the geoheritage value of this structure.

d. JQS matters. In February, prior to the JQS Editorial Board meeting, the President had been visited in Dublin by Sarah Phibbs, Vice-President of Society Management Community / Society Marketing for Wileys, for a 'health-check' meeting. As a result both of that meeting and subsequent correspondence, the President then contacted Wileys in order to begin re-negotiation of our JQS

contract. This has resulted in a draft document from Wileys, which is currently being considered by the Editorial Board (see also item 6c, below).

e. Deceased members. The President sadly reported that several members had passed away: GP Askew, Brian Hawkins, Valerie Hall and Nick Stephens (for whom an obituary had been published in *Quaternary Newsletter* 138).

f. QRA Executive Committee. The President noted several personnel changes to the Executive Committee. Postgraduate Representative Jack Lacey had completed his term of office in September and been replaced by Rachel Devine (Royal Holloway), who had been voted in at the Nottingham Postgraduate Symposium. Tom White (Treasurer) and Emma Pearson (Ordinary Member) were also completing their terms of office at this AGM; the President thanked all outgoing committee members on behalf of the Association for their considerable efforts on the Executive. Tom White has kindly agreed to remain for a further year *ex officio* to advise the incoming Treasurer. In addition, the President was also completing his term of office at this AGM and warmly thanked the Executive Committee members with whom he had worked over the past three years.

5. Honorary Members of the QRA

The President announced that three members had been nominated by the Executive Committee to receive Honorary Member status: Tim Atkinson, Mike Hambrey and Mike Tooley. These nominations were <u>accepted unanimously</u> by the membership and were announced at the meeting with citations that will subsequently appear in a forthcoming issue of QN.

6. Annual Report of the Secretary

The report covered the period January – December 2016.

a. Membership. Total membership of the Association currently stands at **1120** (Table 1). Although this appears to represent a reduction in comparison with the previous few years, it is likely to be a truer reflection of membership levels, coming as it does after a concerted attempt to clean up the database and to remove redundant entries.

The QRA also **co-sponsored** the 2016 INQUA Early Researcher Conference and Summer School (*Using Observations and Modeling to Understand Past Climate Change*), held at the University of Reading in September (organized by John Carson, Macarena Cárdenas, Sandy Harrison and Joy Singarayer).

The **Wiley Annual Lecture** for 2016 was delivered during the Annual Discussion Meeting held at Royal Holloway, University of London, by Sune Rasmussen (Niels Bohr Institute, Copenhagen), entitled *A high-resolution ice-core account of abrupt climatic changes during the most recent glacial period and a look at their governing mechanisms.*

The Executive Committee extends it thanks to the many people who organised meetings, supported the meetings through their participation and who reported on these activities in QN for the information of the wider membership.

c. Publications

Quaternary Newsletter

3 issues: 138 (Feb 2016), 139 (June 2016), 140 (October 2016) Editors: Dr Sven Lukas (Queen Mary) and Dr Abi Stone (Manchester)

During 2016 the Executive sought members' opinions concerning a proposed move to an electronic distribution model of QN. A consultation exercise generated 244 responses, the majority of which (~84 %) supported the move. The results of the consultation were made available to members online, via email and through the Circular. The Executive considered the responses carefully and agreed that, from 2017 onwards, QN would be routinely distributed electronically, though members still wishing to receive a hard copy would be able to do so, subject to the payment of a small subscription surcharge.

Journal of Quaternary Science

Volume 31: containing 79 research papers across eight issues, one of which was a themed special issue (*Quaternary palaeoenvironmental proxies and processes*) consisting of papers in honour of Professor Alayne Street-Perrott (winner of the James Croll Medal in 2015). Editor: Professor Geoff Duller (University of Aberystwyth)

QRA Field Guides

Three new field guides were published: *The Quaternary of Skye* (Ballantyne & Lowe), *The Quaternary Periglaciation of Kent* (Murton & Giles) and *The Quaternary Glaciation of the Mourne Mountains* (Roberson, Barr & Cooper), each produced to accompany QRA field meetings held in 2016.

<u>Discussion</u>. Members were keen to discuss issues around the renegotiation of the JQS contract. The President outlined the main details of the proposal that was currently being considered by the Editorial Board. Several members commented that, whilst the proposed financial terms would undoubtedly prove more beneficial to the Association than currently, they might nevertheless be more generous and that further negotiation would therefore be appropriate. Wiley's current and likely future policy with regard to Open Access (OA) submissions were also raised, especially the Green OA route, with its associated embargo period. Members were particularly concerned that any OA policy should not act as a barrier to submissions from academics currently subject to REF requirements; further specialist consultation on this issue was therefore urged. The President undertook to report members' concerns back to the Editorial Board in order to inform ongoing negotiations with Wiley.

d. QRA Grants and Awards

During 2016, **£26,679** was disbursed by the QRA to 39 of its members under its standard awards schemes (Table 2). The full list of successful applicants is given in Table 3.

QRA Prizes

The 2016 James Croll Medal was awarded to Ian Shennan (Durham). A citation will appear in a future issue of *QN*.

The Awards Officer (Adrian Palmer) thanked the Awards Panel team, namely Tom White, David Bridgland and Emma Pearson, for their consideration of all applications made in 2016. The previous Awards Officer, Erin McClymont, was also thanked for the ongoing help she had provided during the handover.

e. Research Groups and Study Groups

The Research Group scheme is designed to provide a small quantity of start-up funding over a threeyear period for specialist Quaternary research groups, with the aim to bring research communities together, foster communication and provide an opportunity for new research projects to be formulated. The scheme has launched a number of significant research collaborations in the past.

The QRA currently supports one research group, SLaCC, which completes its three-year period of funding at the end of 2018. The aim of the **Sea Level and Coastal Change Research Group** (SLaCC) is to draw together scientists from the UK and NW Europe that are actively researching sealevel and coastal changes and the impact of sea-level change on the coastal environment, in the past, present and future. They organise annual meetings to discuss sea-level and coastal change over a range of time and spatial scales but with particular relevance to vulnerable coastal communities within the UK and NW Europe. Their second meeting was held in 2016 in Whitby and on the NE Yorkshire coast (jointly with the QRA) and a report will appear in a future issue of *QN*. New proposals for research groups are invited at any time and may be discussed with the Secretary in the first instance. These will be put to the membership for approval at the Annual General Meeting.

f. Outreach

As a registered charity, outreach is an important part of our activities and, as our Outreach and External Liaison Officer, Barbara Silva has been pro-active in pushing forward our activities on this front.

QRA Undergraduate Dissertation Prize

The winner of the 2016 prize was Tom Sims for his dissertation entitled *The environmental impact of European settlement in Australia: influences on a patterned fen ecosystem.* The abstract of the winning dissertation will be published in a forthcoming *Quaternary Newsletter*. The Association wishes to thank examiners Ian Candy and Ian Evans, in this their final year acting as judges, and to acknowledge the continuing support of Catherine Souch and others at the RGS for the administration of the prize.

QRA Outreach Award

The QRA encourages its members and others to promote and foster engagement between Quaternary science and a wide and diverse audience. In support, we maintain an annual Outreach fund from which grants are awarded. This year we contributed funding towards an Earth Science Week outreach educational project by the North West Highlands Geopark.

Outreach Awards are normally made of up to £750, although larger requests will be considered – please see the QRA website for a list of previously funded projects. For more details please contact the Outreach Officer (outreach@qra.org.uk).

g. Executive Committee

Four members of the Executive Committee completed their terms of office:

- September 2016: Jack Lacey (Postgraduate Representative)
- January 2017: Professor Pete Coxon (President), Dr Tom White (Treasurer) and Dr Emma Pearson (Ordinary member).

The Executive Committee extends its thanks to all these individuals on behalf of the membership for their hard work and contributions towards the running of the Association throughout their periods in office.

We also welcomed a new postgraduate representative on to the Executive Committee in September, Rachel Devine (Royal Holloway), who will represent the QRA postgraduate community for the next two years.

h. Postgraduate activities

Postgraduate events continue to be an important component of the activities of the Association. The Annual Postgraduate Symposium series continued, with the 2016 event being held at the University of Nottingham in September. The meeting was a success and a full write-up of the event will appear in a future issue of *QN*. Postgraduate interests are represented on the Executive Committee by two members, who are elected at the Annual Postgraduate Symposium (both posts last for two years). The PG representatives also maintain the social media accounts of the Association.

i. Publicity

This year has seen continued development of the functionality and content of the new website, including further improvements to the online bookstore and the submission procedure for grant applications. Further upgrades are in the pipeline. Our Publicity Officer, Bethan Davies, is to be thanked for continuing to oversee the website improvements. Members also now receive mailshots to their email accounts approximately once a week: relevant announcements should be sent to the Publicity Officer for circulation (publicity@qra.org.uk).

j. Conservation

The QRA recognises that geoconservation is particularly important at a time when Quaternary sites are under increasing pressure from development and other human impacts. Recognition of the value of conserving Quaternary sites is vital both for the field-based research and education that are essential to advance the science, and also for the wider benefits for the environment and society. The QRA and its members already carry out many activities that support and promote geoconservation, particularly through field and discussion meetings, as well as offering practical support and working with local groups. The role of QRA Conservation Officer on the Executive Committee (conservation@qra.org.uk) is to support and encourage these activities, as well as to present the QRA's position on conservation issues. To this end, our Conservation Officer, Stewart Campbell, has been busy on the Association's behalf during 2016. Some of the most important initiatives have included:

- (i) Highlighting the geoheritage value of the Callander moraine in the face of revised development plans.
- (ii) Instigating formal support from the Association towards the production of *Earth Heritage* magazine.
- (iii) Amending the Association's Meetings Guidelines document to ensure that geoconservation issues feature prominently in QRA Field (and other) Meetings.
- (iv) In collaboration with the Treasurer and Awards Officer, setting up a QRA Geoconservation Award scheme (further details to follow).

k. QRA Archives

Work has continued throughout the year on the QRA archive project, currently hosted in hard-copy and electronic formats by the RGS-IBG. Hard copies of all Association documentation and correspondence has now been transferred to archive-quality storage. Changes to the website architecture have also been put in hand so that parts of the Association's archive can be made available online to members, subject to consideration of Intellectual Property Rights (IPR). The Executive Committee is also working to establish an image archive in the near future.

The Secretary's report was ACCEPTED by the membership.

7. Treasurer's Report

The Report covers the period 1 August 2015 to 31 July 2016. The Association's financial activities (Table 4) have been comparable to previous years and remain healthy and stable.

a. Income

Income from membership subscriptions, paid directly into our main subscriptions account via standing order, was £12,161.07, representing a small increase on 2014–15. Online book sales, paid directly into our publications account, totalled £1,925.00. In total, our income from subscriptions and book sales amounted to £23,410.12 (similar to last year). The Association continues to receive a significant amount from Wiley as a profit-share from publication of *Journal of Quaternary Science*, which this year totalled £44,055. In addition, royalties disbursed to us by the Publisher's Licensing Society (PLS) amounted to an additional £2,730.91. Overall, the Association's working income for the year (subscriptions, book sales and royalties) is stable at around £70,000.

b. Expenditure

Day-to-day running costs increased slightly to £20,140.81, though this sum is still comparable with previous years. Our budget to support activities through grants, awards and sponsorship was increased by around £4000 this year, to £29,082.62. Note that our INQUA subscription (of £12,612) has not yet been paid for the 2015–16 financial year.

c. Year-End Financial Status

We started the 2015-16 year with £189,760.89 and ended with £215,419.89. As always, the Treasurer will aim to break-even within the financial year.

d. Auditing

The finances have not yet been audited and were submitted to the AGM subject to approval by the external auditor.

<u>Discussion</u>. Members questioned the Treasurer over the accounts and the apparently large surplus held by the Association. The Treasurer explained that around £140,000 of our holdings include ring-fenced sums of more than £20,000 for specific awards and prizes (including the Bill Bishop Award and the Lewis Penny Medal), around £86,000 for the INQUA fund and £30,000 to meet any unexpected liabilities. Members suggested that the Association still held a significant surplus over and above these protected funds and that, in order not to jeopardize our charitable status, we might re-consider our future financial strategy. The President agreed to raise this issue at the next Executive Committee meeting.

8. Publications Secretary's Report

a. New and upcoming titles

Three new Field Guides were published during 2016 relating to Field Meetings held during the year: (1) *The Quaternary of Skye* (Ballantyne & Lowe); (2) *The Quaternary Glaciation of Kent* (Murton & Giles); and (3) *The Quaternary Glaciation of the Mourne Mountains* (Roberson, Barr & Cooper). Feedback on all three had been extremely positive. Several new Field Guides were in the pipeline, corresponding to planned 2017 Field Meetings in the northern Pennines, the Yellow River (China) and the Vale of Pickering.

b. Book sales

This year had seen a 30 % increase in sales over 2015, representing the best year for book sales since 2006 (when records began). New format field guides had been selling especially well, though sales of the *History of the QRA* monograph had been poor. An online book sale was planned for February 2017.

c. Stock levels

Stock levels of pre-2005 Field Guides remains excessively high. In tandem with low sales of many of these titles, storage is proving to be an ongoing problem. Attempts at trying to give away stock to university libraries has also proven unsuccessful. The Executive have therefore made the reluctant decision that, following the February 2017 online book sale, some excess stock will have to be destroyed.

d. Digitisation of Field Guides

Attempts to make out-of-print Field Guides available electronically via the QRA website are ongoing. Around 90 % of pre-2000 Field Guides have been scanned, however major issues concerning digital IPR have been encountered.

<u>Discussion</u>. Members pressed the Publications Secretary for additional details and clarification on the digital IPR issues. During discussion, the benefits of making out-of-print Field Guides available for download were acknowledged across the board, though it was made clear that the Association would not be able to move forward on this matter until a workable solution had been identified. The Publications Secretary assured members that this matter had been under consideration by the Executive Committee for some time and that specialist advice was being sought with a view to making the Field Guides available as soon as practicable.

The Publication Secretary's report was <u>ACCEPTED</u> by the membership.

9. Quaternary Newsletter

The Editor informed members that QN submission guidelines would shortly be changed in order to reflect the additional flexibility that came with the adoption of a dominantly electronic distribution model. For example, there is immediately the scope to include longer articles and colour images. The Editor was also keen to encourage a more diverse range of content, including discussion articles, contributions from Research Groups and commissioned perspective pieces resulting from ADMs / Field Meetings. Members were asked to be creative with future QN submissions and to discuss ideas with the Editor.
